COTERRA'S MOTION TO CONTINUE

Coterra Energy Operating Co., (“**Coterra**”) (OGRID No. 215099), through its undersigned attorney, states the following:

1. By 2nd Pre-Hearing Order dated August 20, 2026 (“PHO”), the Case Nos. 26062-26065 were consolidated with Avant Operating II, LLC’s (“**Avant**”) Case Nos. 25996, 26129, and 26130 and set for contested hearing on September 15, 2026.
2. PHO Paragraph 2 provides that if objections to a hearing by affidavit are subsequently withdrawn, the cases will proceed by affidavit on October 8, 2026.
3. On September 14, 2026, Avant filed its Unopposed Notice of Dismissal of Case Nos. 25996, 26129, and 26130 and an Order was granted for same.
4. Avant was the sole contesting party in the above-referenced cases.

Pursuant to the PHO, Coterra moves to continue the above-referenced cases to October 8, 2026, for a hearing by affidavit.
