APPLICANT'S STATEMENT OF THE CASES

Under these consolidated cases, Greyhound seeks orders pooling all uncommitted interests in the Bone Spring formation (WC-Bone Spring) in the following proposed horizontal well spacing units, all within Township 17 South, Range 37 East, NMPM, Lea County, New Mexico:

- Under **Case No. 26403**, Greyhound seeks an order pooling the uncommitted interest owners in a standard 560-acre, more or less, horizontal well spacing unit underlying the E/2 W/2 of Sections 9, 16, and 21 and E/2 NW/4 of Section 28. MRC seeks to dedicate this horizontal spacing unit to the proposed **Semmelbeck North State Com 132H** well, to be horizontally drilled from a surface location in the S/2 N/2 of Section 28, with a first take point in the SE/4 NW/4 (Unit F) of Section 28, and a last take point in the NE/4 NW/4 (Unit C) of Section 9.
- Under **Case No. 26404**, Greyhound seeks an order pooling the uncommitted interest owners in a standard 560-acre, more or less, horizontal well spacing unit underlying the W/2 E/2 of Sections 9, 16, and 21 and W/2 NE/4 of Section 28. MRC seeks to dedicate this horizontal spacing unit to the proposed **Semmelbeck North State Com 133H** well, to be horizontally drilled from a surface location in the S/2 N/2 of Section 28, with a first take point in the SW/4 NE/4 (Unit G) of Section 28, and a last take point in the NW/4 NE/4 (Unit B) of Section 9.

The completed interval for the wells will comply with statewide setbacks for oil. Greyhound has sought and been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject acreage.
