ORDER OF DISMISSAL

These cases having come before the Director of the Oil Conservation Division ("Division") after a hearing on each case was scheduled on July 15, 2021, the Director, based on the recommendation of the Hearing Examiner, enters the following findings, conclusion and order.

- 1. In each of the above referenced cases ("Cases"), Vista Disposal Solutions LLC ("Vista") applied for an order approving a salt water disposal well. The Cases were filed in December 2019 and January 2020. In each Case, one or more other parties filed entries of appearance.
- 2. After being set for hearing and then continued several times, each of the Cases was set for hearing on July 15, 2021 based on motions for continuance filed by Vista.
- 3. On July 6, 2021, the Padilla Law Firm, P.A. ("Padilla") filed a motion to withdraw as counsel to Vista. The basis for the motion was that Vista had failed to communicate in any way with its counsel and had changed or disconnected its telephone and electronic mail addresses. No other attorney or representative filed an entry of appearance on behalf of Vista.

- 4. Prior to the hearing, Vista did not file pre-hearing statements or motions to continue the Cases.
- 5. At the hearing on July 15, 2021, no person appeared on behalf of Vista. Padilla appeared, affirmed his motion to withdraw and stated that there has been no communication from Vista since the motion was filed. The Hearing Examiner granted the motion to withdraw.
- 6. Other parties in each Case appeared at the hearing and supported the dismissal of the Cases.
- 7. The Director finds that Vista failed to appear at the hearing and failed to prosecute the Cases and concludes that dismissal of the Cases is an appropriate remedy.

IT IS HEREBY ORDERED THAT the applications in the Cases are dismissed without prejudice.
