APPLICATION OF SPUR ENERGY PARTNERS, LLC., TO POOL AN ADDITIONAL WORKING INTEREST OWNERS UNDER THE TERMS OF ORDER NO. R-20642, EDDY COUNTY, NEW MEXICO. CASE NO. 22049 ORDER NO. R-20642-E

<u>ORDER</u>

The Director of the New Mexico Oil Conservation Division ("OCD"), having heard this matter through a Hearing Examiner on August 5, 2021, and after considering the testimony, evidence, and recommendation of the Hearing Examiner, issues the following Order.

FINDINGS OF FACT

- 1. On June 24, 2019, OCD issued Order R-20642 to Spur Energy Partners, LLC ("Operator"), to pool the uncommitted oil and gas interests within the specified spacing unit ("Unit").
- Subsequent to the issuance of Order R-20642, Operator discovered a previously unidentified interest owners in the Unit. Accordingly, R-20642 was amended by Orders R-20642-B, R-20642-C, and R-20642-D to add previously unidentified interest owners. Operator now seeks to amend the aforesaid Order(s) to compulsorily pool to additional previously unidentified interest owners.
- 3. Operator provided evidence that it gave notice of the Application and the hearing to the previously unidentified interest owner.
- 4. Operator presented evidence through affidavits in support of the Application.
- 5. No other party presented evidence at the hearing.

CONCLUSIONS OF LAW

- 6. OCD has jurisdiction to issue this Order pursuant to NMSA 1978, Section 70-2-17.
- 7. Operator is the owner of an oil and gas working interest within the Unit.
- 8. Operator satisfied the notice requirements for the Application and the hearing as required by 19.15.4.12 NMAC.
- 9. OCD satisfied the notice requirements for the hearing as required by 19.15.4.9 NMAC.
- 10. The previously unidentified interest owner has not agreed to commit its interest to the Unit.

- 11. The pooling of the previously unidentified uncommitted interest in the Unit will prevent waste and protect correlative rights, including the drilling of unnecessary wells.
- 12. This Order affords to the previously unidentified interest owner the opportunity to produce its just and equitable share of the oil or gas in the pool.

<u>ORDER</u>

- 13. The previously unidentified uncommitted interest in the Unit is hereby pooled in the Unit.
- 14. Orders R-20642, R-20642-B, R-20642C, and R-20642-D shall remain in full force and effect.
- 15. OCD retains jurisdiction of this matter for the entry of such orders as may be deemed necessary.
