A water tank ran over the top spilling 97 barrels of produced water onto the gravel lined containment and we recovered 95 barrels. The tanks reached high levels due to the pump not turning on, we are still investigating this issue. The safety system on the tank failed to shut the well in when the tank reached high levels due to the safety system being isolated. Impacted gravel was removed to inspect the liner. A liner inspection was scheduled for 4/15/2021.
