Immediate efforts began to identify the nature of the liquid and it was determined to be pH 13 liquid. Based on the area of the release and estimated depth of liquid, an initial estimate of 200bbls of D002 liquid was estimated to have been released to the ground. Approximately 130bbls of liquid was recovered into vacuum boxes which will be managed onsite. Cleanup of contaminated soil/gravel in the affected area is ongoing. Initial investigation indicates the release was caused by a clogged sewer line which allowed water to backup and come into contact with residual caustic in the sewer line.
