Please explain reason for why this event was beyond this operator's control	We were seeing a little lower pressure from Lucid, so we decided to open up 1 well. It produced all day that Saturday, but then early Sunday morning Lucid's line pressure went up and pressured us out. The well flare ESD did not function properly, and it allowed us to accumulate a flare volume over 500 mcf/d. We are investigating why the well did not SI. No notification from Lucid.
Steps taken to limit the duration and magnitude of vent or flare	Cimarex will has fixed its emergency SI to prevent flaring from exceeding over 500 mcf/day.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	As noted emergency shut in has been repaired to prevent flare from exceeding 500/mcf/d
