Cause of Release: On March 15, 2022, Enterprise had a release of natural gas and condensate from the Lateral 2C-45 – McKenzie #2 pipeline. The pipeline was isolated, depressurized, locked and tagged out. No residents were affected. No washes were affected. No emergency services responded. Enterprise began repairs and remediation on April 14, 2022 and determined this release reportable per NMOCD regulation due to the volume of impacted subsurface soil. A third party corrective action report will be submitted with the "Final C-141."


