Steps taken to limit the duration and magnitude of vent or flare	Maljamar gas plant had to back out gas due to high heat most of the day losing Kemnitz Residue units. Several units down at compressor station due to low oil pressure, low suction, and 3rd stage liquid level requiring a restart on all of them.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Backed out gas to bring field pressure to safe levels, restarted units, and resumed normal operations once capable.
