The constituents of concern in the ERDP area consist of light non-aqueous phase liquid (LNAPL), benzene, toluene, ethylbenzene, and xylene (BTEX), and the chlorinated solvents 1,1 dichloroethylene (1,1 DCE), 1,1 dichloroethane (1,1 DCA), and trichloroethylene (TCE). The COCs in the DEHY area consist of LNAPL and BTEX
