Steps taken to limit the duration and magnitude of vent or flare	High suction pressure caused from pipeline having valve shut, due to a leak. Unit 201 down several times on high inlet manifold air and low jacket water temp. Unit 202 down on high discharge temp cylinder 4. Maljamar gas plant also had to back out gas for high residue suction pressure as well as C-111 going down causing some cryo fuel valves to shut.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Had mechanics address each unit, which brought about several start-ups until it was finally back online. Backed out gas as needed, and flared to bring pressures to safe operating levels. Resumed normal operations once capable.
