C-111 going down contributed to some cryo fuel valves shutting down. High suction pressure due to a pipeline having a valve shut due to a leak. Several units went down as well.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Had mechanics work on the pipeline leak, as well as units 312, 313, and 314. Several restarts but once put back online, we backed out gas as needed and resumed normal operations once capable and pressures brought down to a safe operating level.
