Steps taken to limit the duration and magnitude of vent or flare	Maljamar gas plant backed out gas due to issues with Regen 4. Station flaring is due to high inlect suction press. Units 201, 202 and 203 went down several times after each repair due to cat panel failure, high inlet air temp, comp oil pressure, 2nd stage discharge pressure, scrubber levels and 1st stage discharge pressures.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Backed out gas as needed while mechanics were working to complete repairs on regen 4 and the units that were downed. Flared to keep pressures at safe operating levels and resumed normal operations once repairs were complete and safe to do so.
