A pinhole on the collar of the 2H separator resulted in the release of approx. 29 bbl. of produced water inside of the lined, secondary containment. The source was isolated for repairs and the fluid was recovered in tandem to the pressure washing of the containment as it was too shallow to be recovered by truck by the time one became available later that day. 
