Are there additional details for the questions above (i.e. any answer containing Other, Specify, Unknown, and/or Fire, or any negative lost amounts)	On October 26, 2022, HFSinclair Navajo refining became aware that a release in the Tank 834/838 tank dyke, previously believed to be a sheen of diesel on accumulated stormwater, actually contained an appreciable amount of diesel. Based on conversations with operations and the vacuum driver it is believed that >25bbls of diesel was released to stormwater accumulated in the T-834/T-838 tank dyke with a total of 180 bbls of oil and water mixture recovered. Initial investigation indicated that sump adjacent to T-834 had a pump that was not functioning properly. While making repairs to the pump it was identified that the wall of the sump may also be compromised. At this time a limited area surrounding the north and east side of the sump is being excavated to evaluate the condition of the sump wall and determine an appropriate path forward for repairs if needed.
