The flaring can be attributed to VRU down time and the blowers on location being down causing too much oxygen in the system. Tap Rock is analyzing this location and the equipment on location to verify the facility can capture all excess gas. If flaring continues Tap Rock will alter the facility by placing additional gas takeaway equipment.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Tap Rock saw flaring in excess at this location for two reasons. The flaring can be attributed to VRU down time and the blowers on location being down causing too much oxygen in the system.
