On behalf of Concho Operating, LLC (COG), Carmona Resources, LLC has prepared this letter to document site activities for Diamondback 22 State Com 004H (04.11.22). The site is located at 32.035422°, -104.078920° within Unit N, S15, T26S, R28E, in Eddy County, New Mexico (Figures 1 and 2).

### **1.0 Site information and Background**

Based on the initial C-141 obtained from the New Mexico Oil Conservation Division (NMOCD), the release was discovered on April 11, 2022, due to a hole in the bottom of an oil tank inside the secondary containment. It resulted in approximately one hundred and fifty-five (155) barrels of crude oil and one hundred and thirty (130) barrels were recovered. The remainder was absorbed in the pea gravel and will be removed. See figure 3. The initial C-141 form is attached in Appendix B.

### **2.0 Site Characterization and Groundwater**

The site is located within a high karst area. Based on a review of the New Mexico Office of State Engineers and USGS databases, no known water sources are within a 0.50-mile radius of the location. The closest well is located approximately 0.51 miles Southwest of the site in S22, T26S, R28E and was drilled in 1961. The well has a reported depth to groundwater of 120' feet below ground surface (ft bgs). A copy of the associated point of diversion is attached in Appendix C.

### **3.0 NMAC Regulatory Criteria**

Per the NMOCD regulatory criteria established in 19.15.29.12 NMAC, the following criteria were utilized in assessing the site.

- Benzene: 10 milligrams per kilogram (mg/kg).
- Benzene, toluene, ethylbenzene, and total xylenes (BTEX): 50 mg/kg.
- TPH: 100 mg/kg (GRO + DRO + MRO).
- Chloride: 600 mg/kg

On February 23, 2023, Carmona Resources, LLC conducted liner inspection activities to assess the liner's integrity within the facility. Carmona Resources, LLC personnel proceeded to inspect the liner visually. The liner was found to be intact with no integrity issues. Refer to the Photolog.

Based on the liner inspection throughout the facility, no further actions are required at the site. The final C-141 is attached, and COG formally requests closure of the spill. 






# Nearest water wells




# High Karst




