The water overflowed the secondary containment and ran to ground. An onsite vacuum truck was called in to vacuum the water/ground (approximately 30 BBLs of cooling water was recovered). A temporary pump was used to pull the water in the secondary containment back into the Cooling Tower basin to prevent further release.
