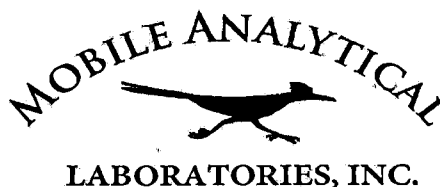

Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	The failed electric motor on the oil pump was restarted. Compression was then restarted, normal operations resumed, and flaring ceased.
