1. Reason why this event was beyond Operator's control:

The emissions event was caused by the unforeseen, unexpected, sudden, and unavoidable interruption, restriction or complete shut-in of a gas pipeline by a third-party pipeline compressor station operator, which impacted Oxy's ability to send gas to them. This interruption, restriction or complete shut-in of the gas pipeline by a third-party pipeline compression station operator is downstream of Oxy's custody transfer point and out of Oxy's control to foresee, avoid or prevent from happening and did not stem from any of Oxy's upstream facility activity that could have been foreseen and avoided, and could not have been avoided by good design, operation, and preventative maintenance practices. In this case, Enterprise, third party operated downstream pipeline operator, had continuing ESD valve issues, which kept closing multiple times within a 24-hr period, which in turn suddenly and unexpectedly shut off their gas intake ability from Oxy, which then prompted high line pressure to occur, which then triggered intermittent flaring events to occur. Oxy makes every attempt to communicate with Enterprise personnel and on this day, there was little to no communication regarding their slam valve issues, which heavily affected Oxy's ability to prevent flaring. Every necessary precaution was taken to ensure that minimization of flaring was done.

2. Steps Taken to limit duration and magnitude of venting or flaring:

It is OXY's policy to route its stranded gas to a flare during an unforeseen and unavoidable emergency or malfunction, that is beyond Oxy's control to avoid, prevent or foresee, to minimize emissions as much as possible as part of the overall steps taken to limit duration and magnitude of flaring. The flare at this facility has a 98% combustion efficiency to lessen emissions as much as possible. In this case, Enterprise, third party operated downstream pipeline operator, had continuing ESD valve issues, which kept closing multiple times within a 24-hr period, which in turn suddenly and unexpectedly shut off their gas intake ability from Oxy, which then prompted high line pressure to occur, which then triggered intermittent flaring events to occur. Oxy makes every attempt to communicate with Enterprise personnel and on this day, there was little to no communication regarding their slam valve issues, which heavily affected Oxy's ability to prevent flaring. Every necessary precaution was taken to ensure that minimization of flaring was done. As soon as flaring was triggered during each instance, Oxy production techs choked back several wells and the field area's mitigation optimizers cut injection rates to wells in the field to reduce injection and sales gas across the area so that field pressure would stay below the flare trigger setpoints of the facility to cease flaring. This event is out of OXY's control, yet OXY made every effort to control and minimize emissions as much as possible.

3. Corrective Actions taken to eliminate the cause and reoccurrence of venting or flaring:

Oxy is unable to take any corrective actions to eliminate the cause and potential reoccurrence of a downstream third-party owned and operated gas plant's issues, as this is downstream of Oxy's custody transfer point and out of Oxy's control to foresee, avoid, prevent from happening or reoccur. Enterprise will have issues which may reoccur from time to time and may trigger a spike in the gas line pressure, which in turn, directly impacts Oxy's ability to send gas to them, which then prompts Oxy to route all its stranded gas not pushed into Enterprise's gas pipeline, to flare. The only actions that Oxy can take and handle that is within its control, is to continually communicate with Enterprise personnel, who own and operate the sales gas pipeline, when possible, during these types of circumstances.
