This interruption, restriction or complete shut-in of the gas pipeline by a third-party pipeline operator is downstream of Oxy's custody transfer point and out of Oxy's control to foresee, avoid or prevent from happening and did not stem from any of Oxy's upstream facility activity that could have been foreseen and avoided, and could not have been avoided by good design, operation, and preventative maintenance practices. In this case, Plains Midstream, third party operated downstream pipeline operator, had an automation glitch on their end, which affected Oxy's ability to continue to send its gas through the sales line, which in turn caused Oxy on-site field personnel to choke back wells. Once Plains Midstream had resolved their automation issue, and re-opened the sales line, the amount of gas surge, once wells were re-opened, overwhelmed the gas compression equipment, and triggered a flaring event. Oxy is unable to predict or anticipate when Plains Midstream will have issues as this is beyond Oxy's control. Every necessary precaution was taken to ensure that minimization of flaring was done during this flaring event. This event could not have been foreseen, avoided or prevented from happening as it occurred with no advance notice or warning.

3. Corrective Actions taken to eliminate the cause and reoccurrence of venting or flaring:

Oxy is unable to take any corrective actions to eliminate the cause and potential reoccurrence of a well surges as wells surge from time to time, which is out of OXY's control. OXY made every effort to control and minimize emissions as much as possible. This incident occurred because several wells flowing to the facility began to surge and unload more gas which overwhelmed the compressor engines.
