It is OXY's policy to route its stranded gas to a flare during an unforeseen and unavoidable emergency or malfunction, that is beyond Oxy's control to avoid, prevent or foresee, to minimize emissions as much as possible as part of the overall steps taken to limit duration and magnitude of flaring. The flare at this facility has a 98% combustion efficiency to lessen emissions as much as possible. In this case, there were issues with the VRUS's malfunctioning all day, which triggered unexpected intermittent flaring instances to occur. During each instance of intermittent flaring which occurred, the facility's well optimizer adjusted injection rates, which prompted flaring to cease. Oxy production techs assisted VRU mechanics with bypassing the VRT and sending production to production tanks to help keep pressure down. Notwithstanding proper VRU design and operation, various forms of mechanical or technical issues can be sudden, reasonably unforeseeable, and unexpected which can cause VRU unit malfunctions to occur without warning or advance notice.
