1. Reason why this event was beyond Operator's control:

This emissions event was caused by the unforeseen, unexpected, sudden, and unavoidable breakdown of equipment or process that was beyond the owner/operator's control and did not stem from activity that could have been foreseen and avoided, and could not have been avoided by good design, operation, and preventative maintenance practices. Oxy engages in respectable and good facility operation practices while also maintaining its continuous facility equipment preventative maintenance program. In this case, Monarch Compression, had to do necessary upgrades to their compression equipment's E-skids and so they had to shut down all compression to perform the necessary work. Monarch compression did not inform Oxy personnel that this work was planned for this date, and Oxy was unaware until they showed up. This event occurred with no advance notice or warning to Oxy and its field personnel from Monarch Compression personnel of their intentions to shut down all its compression equipment. This event is out of OXY's control yet OXY made every effort to control and minimize emissions as much as possible.

2. Steps Taken to limit duration and magnitude of venting or flaring:

It is OXY's policy to route its stranded gas to a flare during an unforeseen and unavoidable emergency or malfunction, that is beyond Oxy's control to avoid, prevent or foresee, to minimize emissions as much as possible as part of the overall steps taken to limit duration and magnitude of flaring. In this case, Monarch Compression, had to do necessary upgrades to their compression equipment's E-skids and so they had to shut down all compression to perform the necessary work. This event occurred with no advance notice or warning to Oxy and its field personnel from Monarch Compression personnel of their intentions to shut down all its compression equipment. As a result of Monarch Compression shutting down all the compression equipment without advance notice to Oxy personnel, this caused the facility to overpressure, which in turn, prompted Oxy's Lost Tank 5 CPF to pressure up, instantly triggering a flaring event to occur. Monarch compression did not inform Oxy personnel that this work was planned for this date, and Oxy was unaware until compression mechanics showed up. As soon as the Oxy production tech, who was on-site, saw flaring occur, he immediately communicated to the well flowback teams to choke back or hold back several wells. The minimal amount of gas flow allowed to be produced and flare was done out of necessity to protect personnel and equipment as a safeguard against potential issues that could occur when restarting the compression equipment. This event is out of OXY's control yet OXY made every effort to control and minimize emissions as much as possible.

3. Corrective Actions taken to eliminate the cause and reoccurrence of venting or flaring:

Oxy is unable take any corrective actions to eliminate the cause and potential reoccurrence for flaring due to a third-party compression vendor doing upgrades to their own equipment as this is out of Oxy's control to foresee, avoid, prevent from happening or reoccur. Third party compression equipment owners may trigger events to reoccur from time to time during maintenance, upgrades or troubleshooting work, which in turn, prompt over pressuring of a facility. The only actions that Oxy can take and handle that is within its control, is to continually attempt to communicate or possibly assist third party owner's personnel during these circumstances, to avoid an emissions event or to potentially minimize one, should one occur.
