The generator tripped leading to a loss of power on the Tox. The air and process blower ion the Tox shut down and the propane from the combustion chamber due to the blowers being shutdown and the propane assist gas went into their fail close state. The propane valve that is supposed to isolate the propane from combustion chamber. Because there was no air in the combustion chamber due to the blowers being shutdown the combustion chamber become fuel rich and unburned propane flowed out of the stack. That propane ignited when it found the oxygen in the ambient air causing the fire that came out of the stack. This lasted for approximately 60 seconds until the Tox closed the manual isolation valve to the propane line. The calculated loss is 0.186 gallon.
