1. Reason why this event was beyond Operator's control:

In this case, Oxy's automation personnel were working on the facility's RIO panel #2, when it suddenly and unexpectedly tripped, causing a power outage to the automated high pressure flare valve, which with the loss of power caused it to open and a brief flaring event to occur. This event could have been prevented had the high-pressure flare valve been manually closed for maintenance, but it was not expected for the RIO panel #2 to trip and a power outage to occur and therefore, this event was beyond Operator's control.

2. Steps Taken to limit duration and magnitude of venting or flaring:

It is OXY's policy to route its stranded gas to a flare during an unforeseen and unavoidable emergency or malfunction, that is beyond Oxy's control to avoid, prevent or foresee, to minimize emissions as much as possible as part of the overall steps taken to limit duration and magnitude of flaring. In this case, Oxy's automation personnel were working on the facility's RIO panel #2, when it suddenly and unexpectedly tripped, causing a power outage to the automated high pressure flare valve, which with the loss of power caused it to open and a brief flaring event to occur. This event could have been prevented had the high-pressure flare valve been manually closed for maintenance, but it was not expected for the RIO panel #2 to trip and a power outage to occur. As soon as the power outage occurred, and flaring was triggered, the automation technician quickly restored power to the panel.
