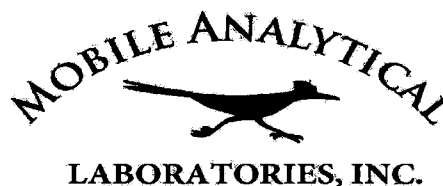

The I to P speed control malfunctioned causing an unexpected shutdown of a compression unit causing gas to be routed to flare for the safety of personnel and equipment.
Steps taken to limit the duration and magnitude of vent or flare	Operations personnel responded immediately to the unexpected shutdown. I&E personnel was contacted to repair the I to P speed control.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	I&E personnel repaired the I to P controller, unit was restarted and the emission event ended.
