Please explain reason for why this event was beyond this operator's control	Third party takeaway pipeline company closed their valve on us for unknown reason. This caused high discharge pressure and resulted in compressors shutting down and flaring.
Steps taken to limit the duration and magnitude of vent or flare	All wells were shut in due to flaring event, to stop flaring. Third party was called out to reopen their valve, and pressures stabilized, compressors restarted. All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas flared
