Please explain reason for why this event was beyond this operator's control	Compressors 1700 and 1800 when down due to a high inlet vessel liquid level. The liquid dump controller wouldn't open at the setpoint because the solenoid was stuck closed.
Steps taken to limit the duration and magnitude of vent or flare	Production was curtailed to limit flaring. Operations proceeded to clean out the solenoid, which drained the inlet sep, and restart compressors. All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas flared.
