The tubing on the 3/8" stainless steel sensing line for tubing pressure PT pulled out of the ferrule. The tubing was not properly set and crimped. This incident resulted in an estimated release of 2.15 barrels of oil and 5.54 barrels of produced water onto the well pad. Vac trucks were able to recover 1 barrel of oil and 3 barrels of produced water from the well pad. The impacted soils will be scheduled for remediation in the coming weeks. Released: 7.7 barrels (2.15 barrels oil + 5.54 barrels produced water) Recovered: 4 barrels (1 barrel oil + 3 barrels produced water)
