Please provide any additional details on why this incident should be cancelled	The location is not reported. There is no latitude/longitude, county, section, township, range or unit number. There is not a well or facility name reported either. Per the details of the spill, "LEAK WAS FOUND BY LEASE OPERATOR WHILE INSPECTING FLOWLINES. THE LEAK WAS A 1/8 HOLE ON BOTTOM OF 3" FLOWLINE CAUSED BY INTERNAL CORROSION. A REPAIR CLAMP WAS PUT ON LINE. LANDOWNER WAS NOTIFIED AND SITE WAS CLEANED UP. LEAK WAS MOSTLY PRODUCED WATER WITH A SKIM OF OIL ON TOP. IT SOAKED INTO THE GROUND AND MEASURES 45"X51"X6" DEEP." Using the 45" x 51" x 6", this calculates to 13,770 cubic inches = 8 cubic feet. At 100% porosity, it would be a 1.42 bbl spill, which is less than five bbls.
