Please explain reason for why this event was beyond this operator's control	On March 15, 2026, the site was required to initiate flaring due to elevated line pressures at the Kinetik Midstream Holdings Maljamar Gas Plant.
Steps taken to limit the duration and magnitude of vent or flare	EPN Flare is only used during upsets and emergencies. The flare is operated with best management practices during flaring events.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Operations adjusted the flare Kimray regulator and increased the vessel pressures. Maverick is currently looking into potential future solutions to reroute gas to avoid flaring.
