



David,

We have received APDs from Yates Petroleum Corporation and Preston Exploration, LLC at the same location: *Section 29, T-18-S R-26-E, 1200' FNL & 1800' FEL, Eddy County, New Mexico.*

Yates Petroleum submitted on *OCD On-Line* their drilling application on March 12th, 2004.

The drilling application from Preston Exploration, LLC has been received by our office today, by mail, on March 15th, 2004.

Both wells regardless of who are the first ones to submit cannot have their APD approved at this time.

This is due to the fact that the well locations lie within the pool boundaries of the Atoka; Pennsylvanian Gas Pool which has special spacing requirements. Neither APD conforms to the special pool rules of the Atoka; Pennsylvanian Gas Pool.

I intend to deny, by letter, Preston's drilling application due to the fact that:

- 1) Yates Petroleum has submitted an APD at the same location prior to heir's.
- 2) The application received does not conform to the special rules of the Atoka; Pennsylvanian Gas Pool and would need to be set for hearing an order to have a well drilled at this location.

I will send another letter to Yates Petroleum, although it is not the OCD's responsibility, that their application cannot be approved until they meet the conditions of item (2) above.

Both operators will receive each other's letter.

No, That is not correct at this time as I wanted to do more research into the Atoka; Pennsylvanian Gas Pool rules. I did not wish to note that in my letter before I referenced something that possibly would not be correct. R.W. Byram's does not show in my book that part of R-8170 was suspended for location requirements. R-Order 8170 has about 25 amendments. The Yates e-mail did not go out yet as the e-mail I had for them is incorrect.
