ORDER OF THE DIVISION

BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on January 8, 2004, at Santa Fe, New Mexico, before Examiner David R. Catanach.

NOW, on this 14<sup>th</sup> day of January, 2004, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

FINDS THAT:

(1) Due public notice has been given, and the Division has jurisdiction of this case and its subject matter.

(2) There is need for the creation of a new pool in Chaves County, New Mexico for the production of gas from the Siluro-Devonian formation, bearing the designation of Bosque-Siluro-Devonian Gas Pool (Pool Code 97318). The Bosque-Siluro-Devonian Gas Pool was discovered by the Yates Petroleum Corporation Aikman "BDK" State Com. Well No. 1 (API No. 30-005-61804) located in Unit P of Section 36, Township 6 South, Range 26 East, NMPM, which was completed in the Siluro-Devonian formation on October 23, 2003. The top of the perforations is at 6,070 feet.

(3) There is need for the creation of a new pool in Eddy County, New Mexico for the production of gas from the Strawn formation, bearing the designation

of West McKittrick Hills-Strawn Gas Pool (Pool Code 97315). The West McKittrick Hills-Strawn Gas Pool was discovered by the Yates Petroleum Corporation McKittrick "ATS" State Well No. 1 (API No. 30-015-29105) located in Unit D of Section 16, Township 22 South, Range 24 East, NMPM, which was completed in the Strawn formation on May 10, 2003. The top of the perforations is at 9,510 feet.

(4) There is need for the creation of a new pool in Eddy County, New Mexico for the production of gas from the Bone Spring formation, bearing the designation of McMillan Escarpment-Bone Spring Gas Pool (Pool Code 97316). The McMillan Escarpment-Bone Spring Gas Pool was discovered by the Pogo Producing Company State "19" Com Well No. 2 (API No. 30-015-32612) located in Unit L of Section 19, Township 20 South, Range 27 East, NMPM, which was completed in the Bone Spring formation on October 10, 2003. The top of the perforations is at 5,508 feet.

(5) There is need for the creation of a new pool in Chaves County, New Mexico for the production of oil from the Siluro-Devonian formation, bearing the designation of Mesa Diablo-Siluro-Devonian Pool (Pool Code 97317). The Mesa Diablo-Siluro-Devonian Pool was discovered by the Yates Petroleum Corporation Starkissed "AWS" State Well No. 2 (API No. 30-005-63539) located in Unit E of Section 3, Township 10 South, Range 27 East, NMPM, which was completed in the Siluro-Devonian formation on September 18, 2003. The top of the perforations is at 6,756 feet.

(6) There is need for the abolishment of the Fren-Pennsylvanian Gas Pool (Pool Code 77160) in Eddy County, New Mexico in order to correct nomenclature.

(7) There is need for extensions to the Burton Flat-Morrow Gas Pool, the East Carlsbad-Morrow Gas Pool, the East Carlsbad-Strawn Gas Pool, the North Cedar Lake-Morrow Gas Pool, the Southeast Cemetery-Morrow Gas Pool, the Crozier Bluff-Atoka Gas Pool, the North Hackberry-Morrow Gas Pool, the Northeast Happy Valley-Strawn Gas Pool, the Indian Basin-Upper Pennsylvanian Associated Pool, the Ingle Wells-Delaware Pool, the Kennedy Farms-Morrow Gas Pool, the Loco Hills-Paddock Pool, the Nash Draw-Delaware Pool, the Nash Draw-Morrow Gas Pool, and the Northeast Red Lake-Glorieta-Yeso Pool, all in Eddy County, New Mexico; and the Crockett Draw-Wolfcamp Gas Pool, the Foor Ranch-Wolfcamp Gas Pool, and the Pecos Slope-Abo Gas Pool, all in Chaves County, New Mexico.

IT IS FURTHER ORDERED THAT:

(1) Pursuant to Section 70-2-18, NMSA, 1978, an operator of any well that, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one presently dedicated thereto, shall have 60 days from the effective date of this order to file Form C-102 dedicating a standard unit for the pool to that well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within that 60-day period shall subject the well to cancellation of allowable.

(2) The effective date of this order and all creations, abolishments, and extensions included herein shall be February 1, 2004.
