Salty Dog Inc. BW-011 Moran well #1 API # 30-025-07374 located in Sec 20-Ts18s-R38e 1650 FNL and 1650 FEL

This well was also assigned a new API # 30-025-35706 in 2002 or 2003. The reason for the new number was the fact that the New Mexico Environment Department (EID) at one time permitted these types of wells and did not issue API numbers and well files were maintained in their permit system. When OCD regained authority on June 13, 1989 there were probably no OCD well records for the wells in question.

History: Record review by Wayne Price showed that Salty Dog, Inc. made a Discharge Plan proposal to EID to re-entered the old Moran well #1 API # 30-025-07374 located in Sec 20-Ts18s-R38e 1650 FNL and 1650 FEL and complete as a brine well. The NMED issued an Approved Permit DP-353 on April 08, 1985. A letter dated November 22, 1988 by New Tex Oil Co. (Nolan H. Brunson Jr.) requested plugging Bond cancellation because the well was never re-entered. EID approves termination of DP Dec 06, 1988.

It is my understanding that you have cancelled the new API # 30-025-35706 and all information pertaining to the brine well will be placed in the old well file API # 30-025-07374.

I have attached the letters mentioned above so for your reference and Lawrence has put them in the 30-025-07374 file.



Hello Everyone:

In accordance with OFS Policy and Procedure OFS-133:

**III. ADHERENCE TO POLICY**

Division telecommunication officers do not have to distribute telephone bills among the employees in their division for review and verification of long distance calls. However, supervisors shall have access to any of their employees' records upon request. An employee's failure to comply with this policy may result in disciplinary action.

Prior to this change in the "Telephone Use" policy, I was disseminating the monthly billings statements to the appropriate Division Telecommunication Officer for review. Once this policy went into effect I stopped disseminating the monthly billing statements, since that time I have had requests for these statements. Do you still want to continue receiving these statements for your review and records? I currently have hard copies starting with the month of October, 2003 through March, 2004, and will be distributing these billings statements to each of your Division Telecommunication Officers for review.
