Great Western Drilling Ltd. hereby seeks administrative approval pursuant to the provisions of Division Rule 104 F (2)-(4) adopted on August 12, 1999, of an unorthodox well location for its Coats Com Well No. 1 to be drilled at an unorthodox gas well location 990 feet from the North and East lines (Unit A) of Section 19, Township 18 South, Range 26 East, N.M.P.M., Eddy County, New Mexico. This well is located in the Atoka-Pennsylvanian Gas Pool that is governed by Special Pool Rules and Regulations adopted by Order No. R-8170, dated March 28, 1986, as amended.

This location in the Atoka and Morrow formation is unorthodox because Rule 2(b) of the Special Rules and Regulations for the Atoka-Penn Gas Pool that provide that "Each well completed or re-completed in the Atoka-Pennsylvanian Gas Pool shall be located in the northwest quarter or southeast quarter of the section and shall be located no nearer than 990 feet to the outer boundary of the quarter section nor nearer than 330 feet to any governmental quarter-quarter section line...." A standard 320 acre spacing and proration unit comprised of the E/2 of Section 19 will be dedicated to the well.

The proposed unorthodox well location is located 990 feet from the outer boundary of the quarter section and 330 feet from all interior governmental quarter-quarter section lines. The location is unorthodox because it is in the northeast quarter of this section.

The proposed unorthodox location is required by geologic conditions. Great Western Exhibit A is a Middle Morrow B Sand Gross Isopach map. This map shows that the Coats Com

Well No. 1 intercepts a Morrow sand channel trending northwest to southeast across the northeast quarter of Section 19. A location is the NE/4 is required to intercept this channel and access these reserves.

Attached hereto as Exhibit B is a plat that shows the subject area, the 320-acre spacing unit comprised of the E/2 of Section 19 and the proposed unorthodox location. 


