Division Order PLC-142 is hereby amended. The resulting order reads as follows.

The New Mexico Oil Conservation Division (OCD) hereby authorizes Amerada Hess Corporation (Amerada) to surface commingle oil, water, and gas production from Amerada operated wells in these pools and acreage.

All located in Township 20 South, Range 38 East, NMPM, Lea County, New Mexico.
