Dear Ms. Maddox:

Reference is made to your recent application for a 2nd amendment to Division Order No. DHC-93, dated January 21, 1998, which order authorized the downhole commingling of Blinebry, Tubb and Drinkard Pool production within the subject well. It is our understanding that the Drinkard zone in the well has been cement squeezed and will no longer be produced. It is further our understanding that the Blinebry and Tubb zones will continue to be commingled in the wellbore.

It appearing that the subject well qualifies for approval for such amendment pursuant to the provisions of Rule 303.C., and that reservoir damage or waste will not result from such downhole commingling, and correlative rights will not be violated thereby, you are hereby authorized to commingle the production as described above and any Division Order which authorized the dual completion and required separation of the zones is hereby placed in abeyance.

In accordance with the provisions of Rule 303.C., the daily allowable producing rates from the subject well are hereby established as follows:

Oil 107 B/D Gas 428 MCF/D Water 214 B/D

Production from the subject well shall be allocated as follows:

Gas and oil production from the Blinebry Oil & Gas Pool shall be determined utilizing the annual production forecast submitted by the applicant as an attachment to the downhole commingling application. Gas and oil production from the Tubb Oil & Gas Pool shall be determined by subtracting Blinebry Oil & Gas Pool production from the well's total monthly gas and oil production.


