Application for Downhole Commingling Lockhart B-35 Well No. 2,
Unit B Section 35, T-21S, R-37E, Lea County, New Mexico

Continental Oil Company, P. O. Box 460, Hobbs, New Mexico, as operator of the Lockhart B-35 Lease, respectfully requests administrative approval under the provisions of Order No. R-3845, to commingle in the well bore production from Blinebry Oil and Wantz Abo Oil Pools in the subject well. This dual completion was authorized by Administrative Order No. ~~DC-221~~ MC-1783. The attached plat shows the Lockhart B-35 Lease outlined in red and the No. 2 well by the red circle.

On October 4, 1971, the bottom hole pressure in the Blinebry and Wantz Abo were measured in the Lockhart B-35 Well No. 2. The Blinebry pressure was measured to be 900 psi after being shut-in for 24 hours. The Wantz Abo pressure was measured to be 693 psi after being shut-in for 24 hours.

Attached is Form C-116 indicating the latest well tests. Also attached is a production decline curve for each zone. Anticipated production from the well after commingling is 40 BOPD by pumping.

The fluid from these two pools has been commingled at the battery for a number of years and there has been no indication of incompatibility. Both crudes are typical Permian high gravity crude.

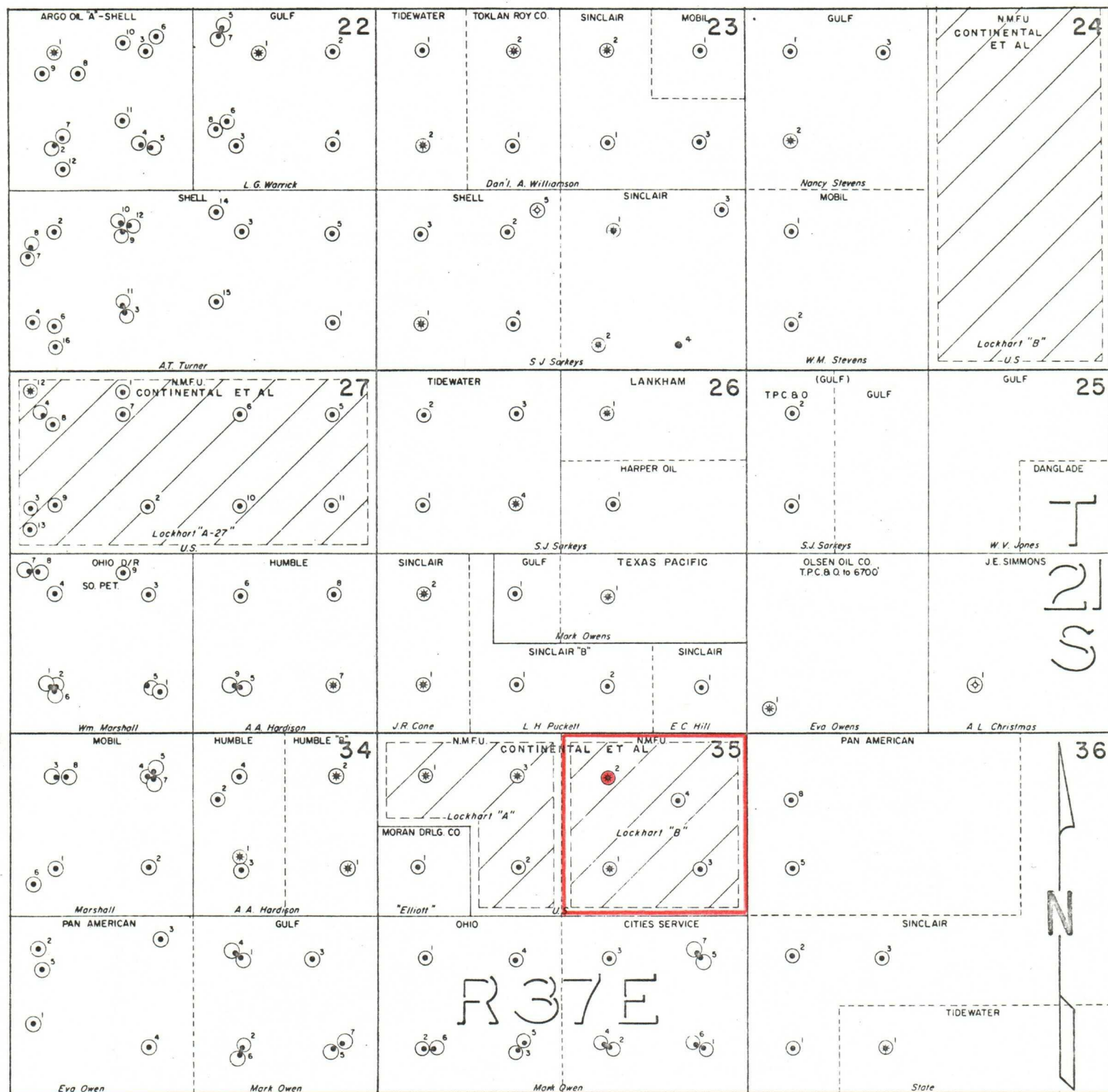

I hereby certify that the above information is true and complete to the best of my knowledge and belief.

No well will be assigned an allowable greater than the amount of oil produced on the official test.
During gas-oil ratio test, each well shall be produced at a rate not exceeding the top unit allowable for the pool in which well is located by more than 25 percent. Operator is encouraged to take advantage of this 25 percent tolerance in order that well can be assigned increased allowables when authorized by the Commission.
Gas volumes must be reported in MCF measured at a pressure base of 15,025 psia and a temperature of 60° F. Specific gravity base will be 0.60.
Report casing pressure in lieu of tubing pressure for any well producing through casing.
Mail original and one copy of this report to the district office of the New Mexico Oil Conservation Commission in accordance with Rule 301 and appropriate pool rules.
