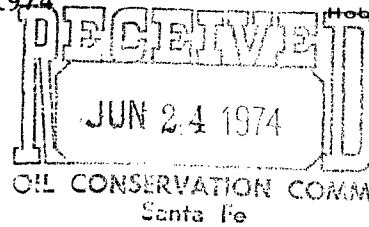

Dear Sir:

Gulf Oil Corporation requests your administrative approval for downhole commingling of the Vacuum San Andres and North Vacuum Abo production in its Ritts State No. 2, located 2080' FNL and 560' FEL, Section 21, 17-S, 34-E, Lea County, New Mexico.

We believe this well qualifies for administrative approval in accordance with Statewide Rule 303, Paragraph C, and in support of this application the following facts are submitted:

1. The attached plat shows the Ritts State lease outlined in red and is described as the NE/4, Section 21, 17-S, 34-E, Lea County, New Mexico, with subject well outlined in red.
2. The well was completed on February 27, 1972 in the North Vacuum Abo pool, flowing 118 BOPD thru perforations 8853' to 8881'. Pumping equipment was installed in March, 1972 and production steadily declined to an average of 25 BOPD and 1 BWPD in April 1974. See attachment for production decline curve for this zone.
3. On May 19, 1974 a retrievable bridge plug was set in 5-1/2" casing at 4797' and the Vacuum San Andres zone perforated with 2, 1/2" JHPF at 4696-98', 4702-04', 4709-11' and 4722-24'. This zone was treated with 4,000 gallons of 15% NE acid and frac treated with 17,000 gallons of gel water. Well was then swab tested at approximately 15 BOPD plus 3 BWPD.
4. The commingling will not result in any appreciable reduction of oil value, and both zones are compatible.
5. Each zone would require artificial lift, therefore, in view of the marginal production and the problems involved in dual completing in 5-1/2" casing, would not be economically feasible to operate as a conventional dual completion.
6. The ownership of the two zones to be commingled are common.
7. Copies of this application have been furnished all offset operators.

Your early consideration in this matter will be appreciated.

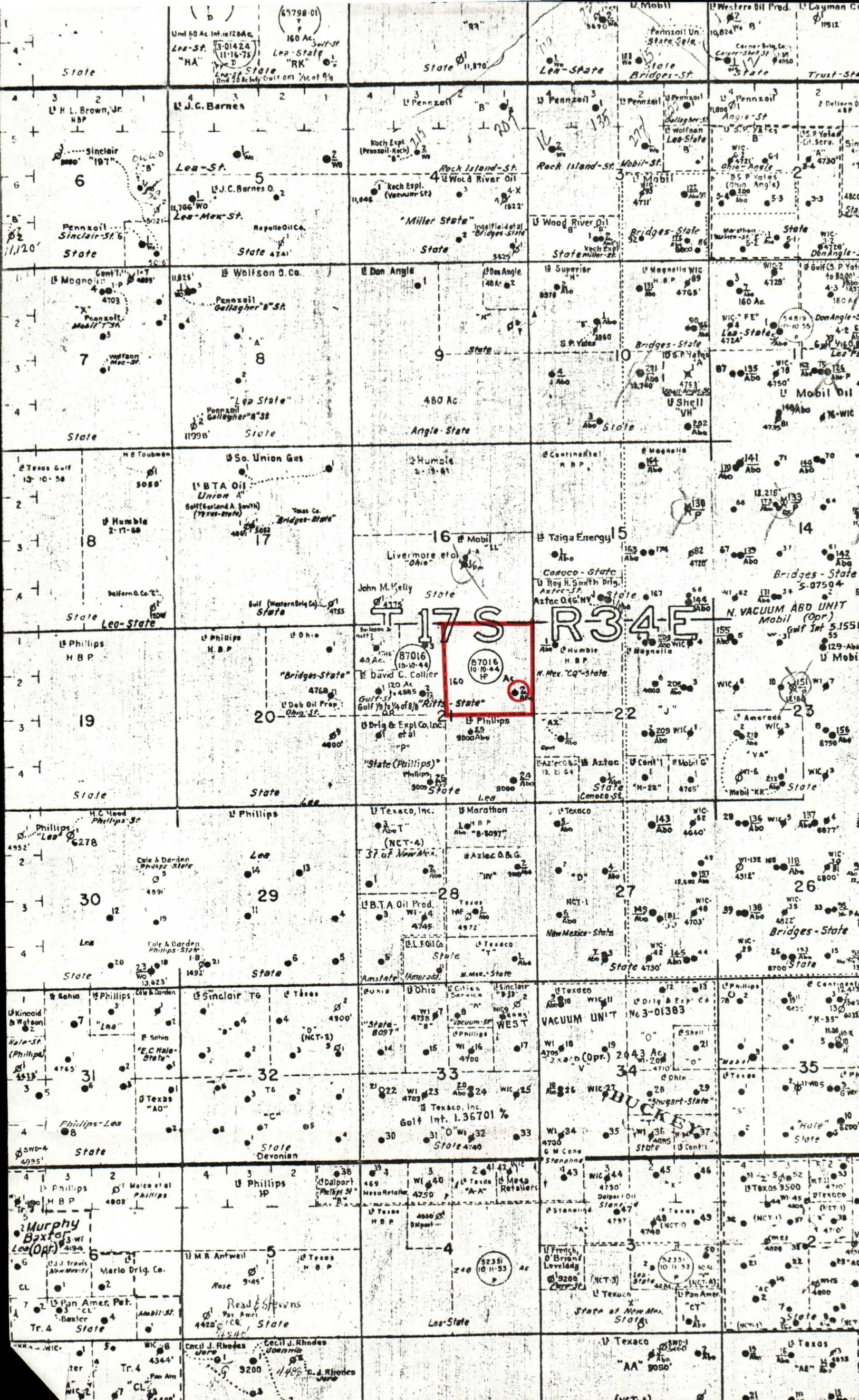

All Offset Operators

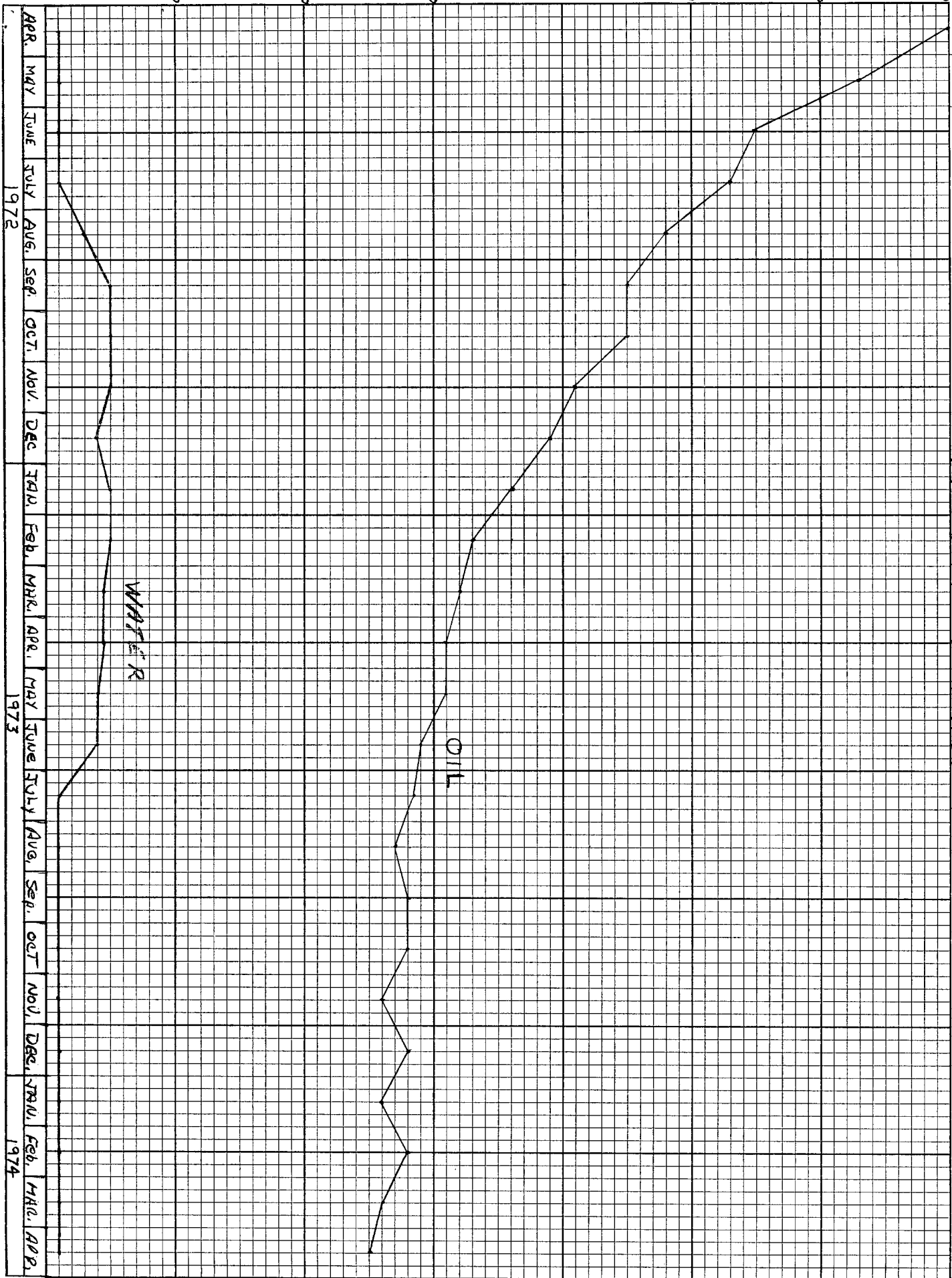
