Production from the Fruitland pool is to be included in a 218.36 acre gas spacing and proration unit in Section 24 comprising of the east half (E/2) of Section 24, which includes the west half of the east half (W/2 E/2) and Lots 1,2,3 and 4. At 218.36 acres, this proration unit is less than the 70% of 320 acres allowed under Order R-8768 as amended. We have checked with the Aztec office of the New Mexico Oil Conservation Division, and could not find a non-standard proration unit order covering this drill block.


