Gentlemen:

We request administrative approval for a Pictured Cliffs and Chacra formations commingled completion of the Jicarilla "B" Well No. 19 located in Unit N of Section 31, T25N, R5W. Rio Arriba County, New Mexico.

We expect a production rate of approximately 60 MCF/D from the Pictured Cliffs and 40 MCF/D from the Chacra. Static reservoir pressures are expected to be of about equal magnitude at approximately 300 pounds per square inch. Allocation of production will be 60% credited to the Pictured Cliffs and 40% credited to the Chacra.

A schematic of the proposed completion is attached.




