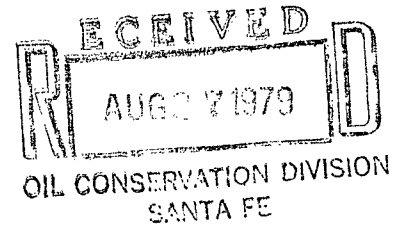

Dear Sir:

ARCO Oil and Gas Company requests administrative approval under the provisions of Rule 303-C to downhole commingle Blinebry and Tubb-Drinkard production in the Jal Federal No. 2. This well is located in Section 11, T-25S, R-37E of Lea County, New Mexico.

Production from the Blinebry and Tubb-Drinkard zones has been commingled in the surface lease facilities (Order #PC-164) with no indication of fluid incompatibility. Since the crudes are commingled at the battery before sale, no difference in value will result from commingling the production downhole. Ownership of both zones is common, and correlative rights will not be violated.

Producing from a maximum depth of 6114', this well is allowed a commingled production rate of 40 BOPD. The water production limit is 40 BWPD from each zone.

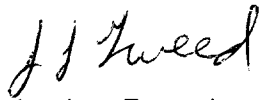
The Jal Federal #2 produces 22 BOPD + 24 BWPD + 76 MCFPD from the Blinebry and 22 BOPD + 5 BWPD + 102 MCFPD from the Tubb-Drinkard with established decline rates. Current bottom hole pressures were measured to be 977 psig for the Blinebry and 625 psig for the Tubb-Drinkard. Both zones are producing by natural flow.

During gas-oil ratio test, each well shall be produced at a rate not exceeding the top unit allowable for the pool in which well is located by more than 25 percent. Operator is encouraged to take advantage of this 25 percent tolerance in order that well can be assigned increased allowables when authorized by the Division.

Gas volumes must be reported in MCF measured at a pressure base of 15.025 psia and a temperature of 60° F. Specific gravity base will be 0.60.

Report casing pressure in lieu of tubing pressure for any well producing through casing.

Well original and one copy of this report to the district office of the New Mexico Oil Conservation Division in accordance with Rule 301 and appropriate pool rules.
