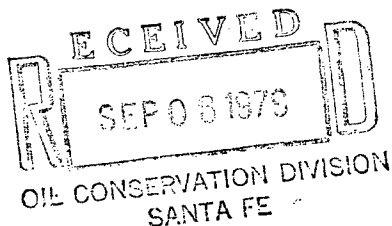

Gentlemen:

TEXACO Inc. respectfully requests Administrative approval to commingle production from the Justis Blinebry and Justis Tubb Drinkard pools in the wellbore of the C. C. Fristoe "B" NCT-2 Well No. 9 in accordance with NMOCD Rule 303-C.

This well meets all prerequisites for downhole commingling, as described in NMOCD Rule 303-C,1, (a thru h) except (c). TEXACO Inc. requests special consideration be given this requirement. The Justis Blinebry was flowing when it was shut-in, 11-8-78, but was weak and with declining bottom hole pressure. The well would not be capable of flowing. The Justis Tubb Drinkard was pumping when it was shut-in 7-2-65. The commingled zones will be pumped.

These zones have been surface commingled and downhole commingled on this lease and others in the field and no incompatibility, between the fluids, has been found.

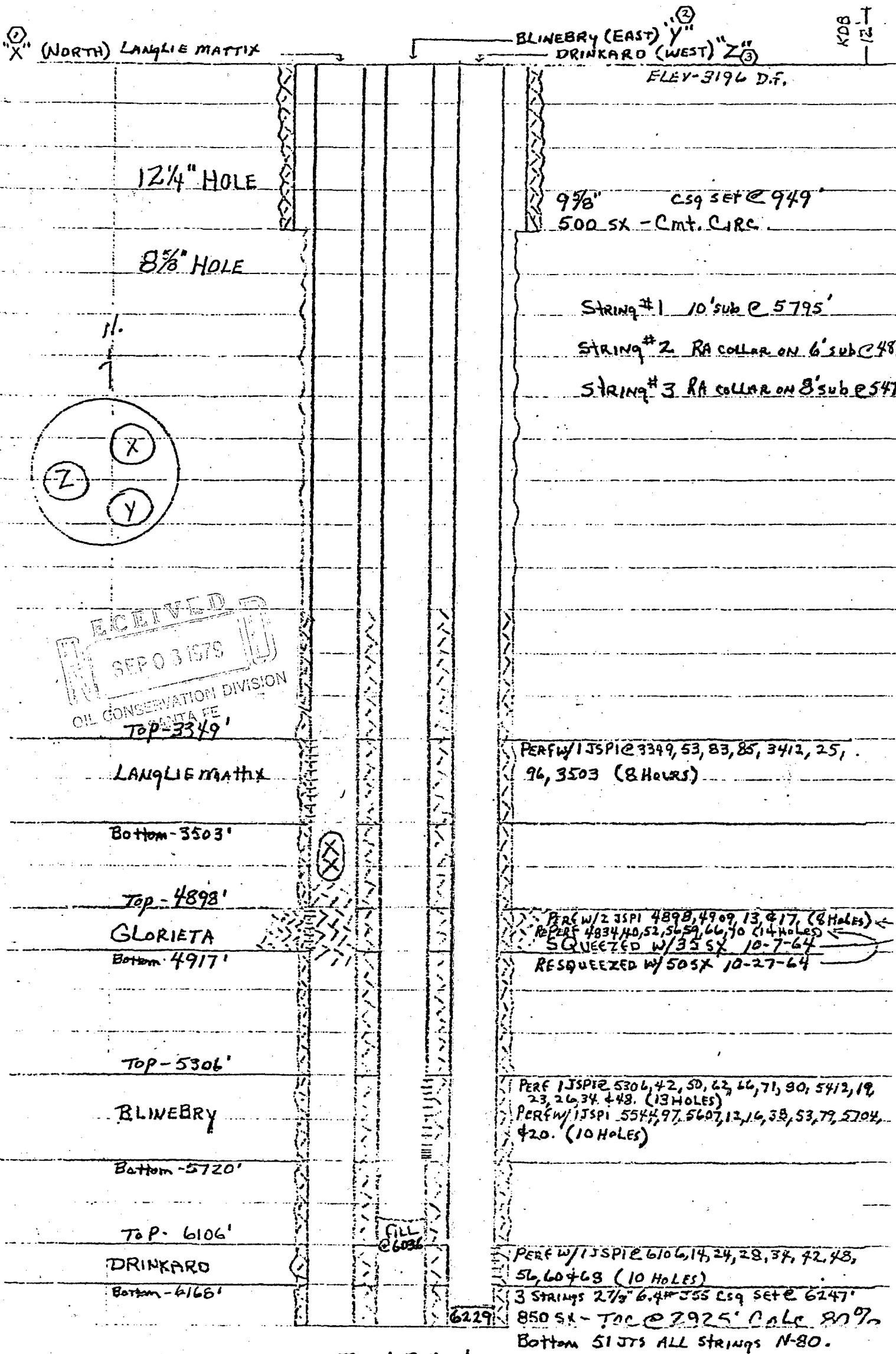


(X) LEFT 2 1/2" SWAB - SINKER BAR & APPROX 750' SAND LINE IN HOLE 11-4-64.

PROPOSED WELLBORE DIAGRAM

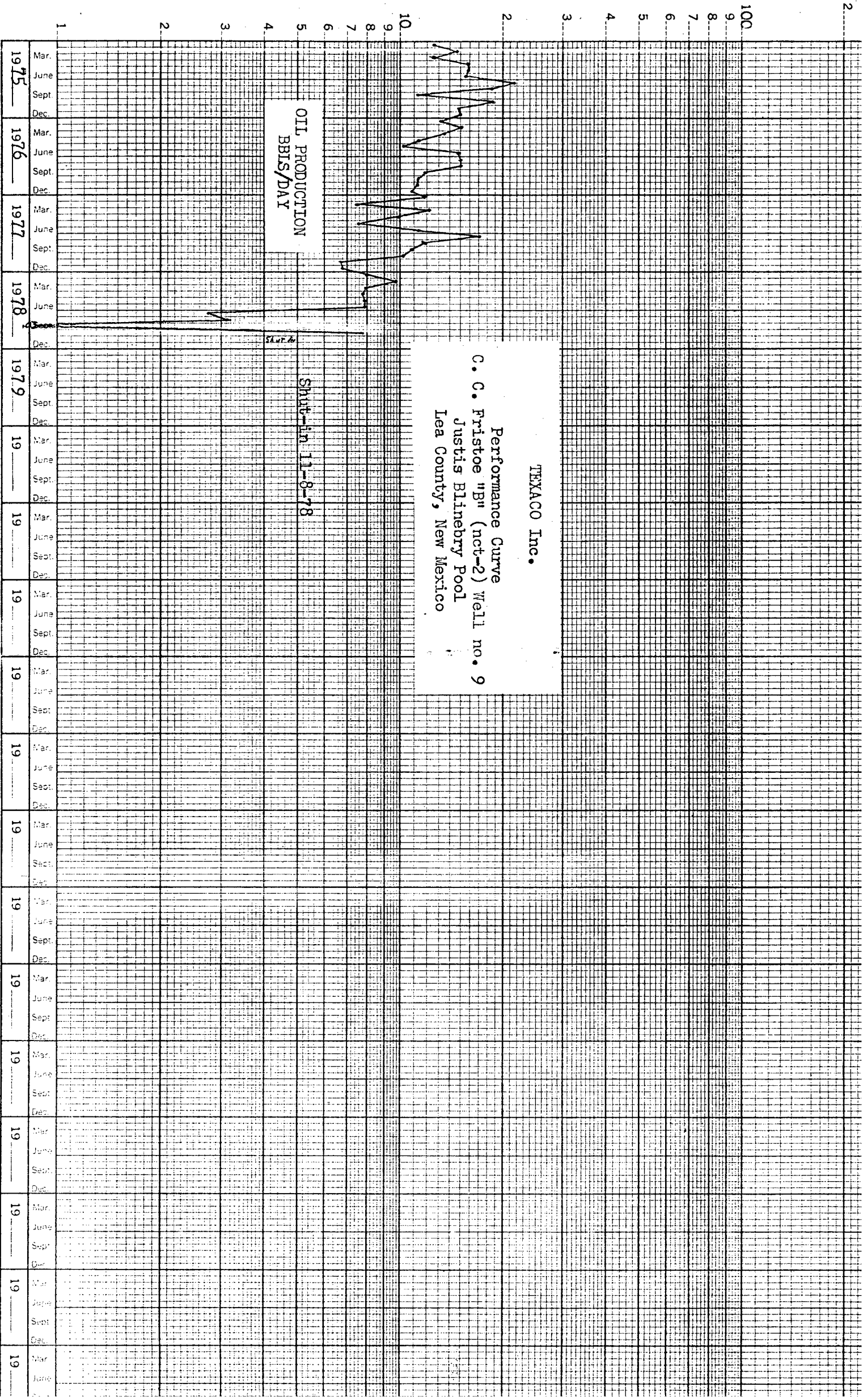

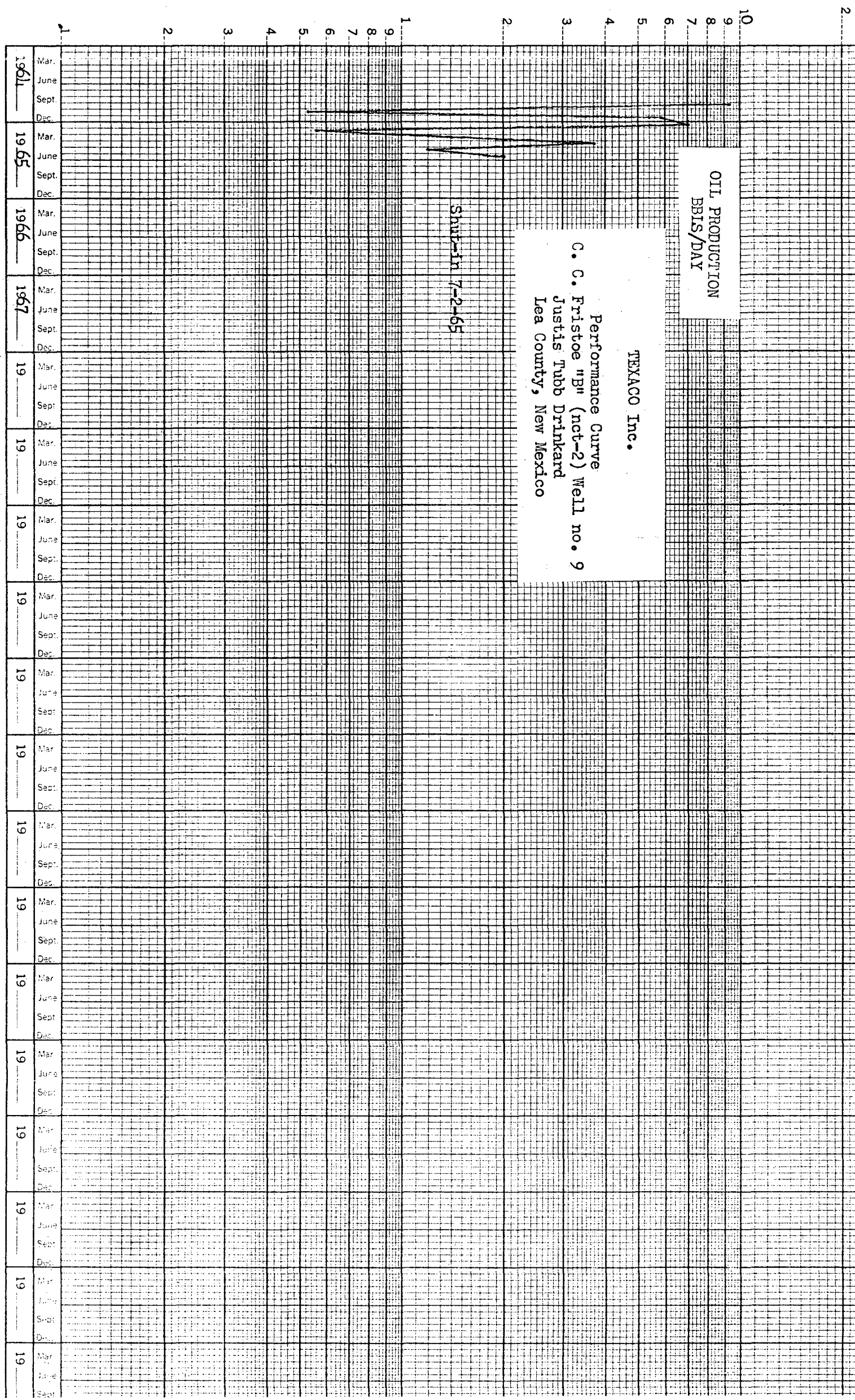


① LEFT 2 1/2" SWAB - SINKER BAR & APPROX. 750' SAND LINE IN HOLE 11-4-64.

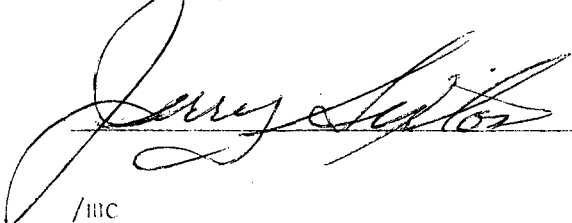
