Division Order No. PLC-142 is hereby amended. The resulting order reads as follows.

NOTE: The commingled production shall be stored in the Warren McKee and Fred Turner Jr. "A" tank battery facility located in the NE/4 SE/4 of Section 18, Township 20 South, Range 38 East, NMPM, Lea County, New Mexico.
