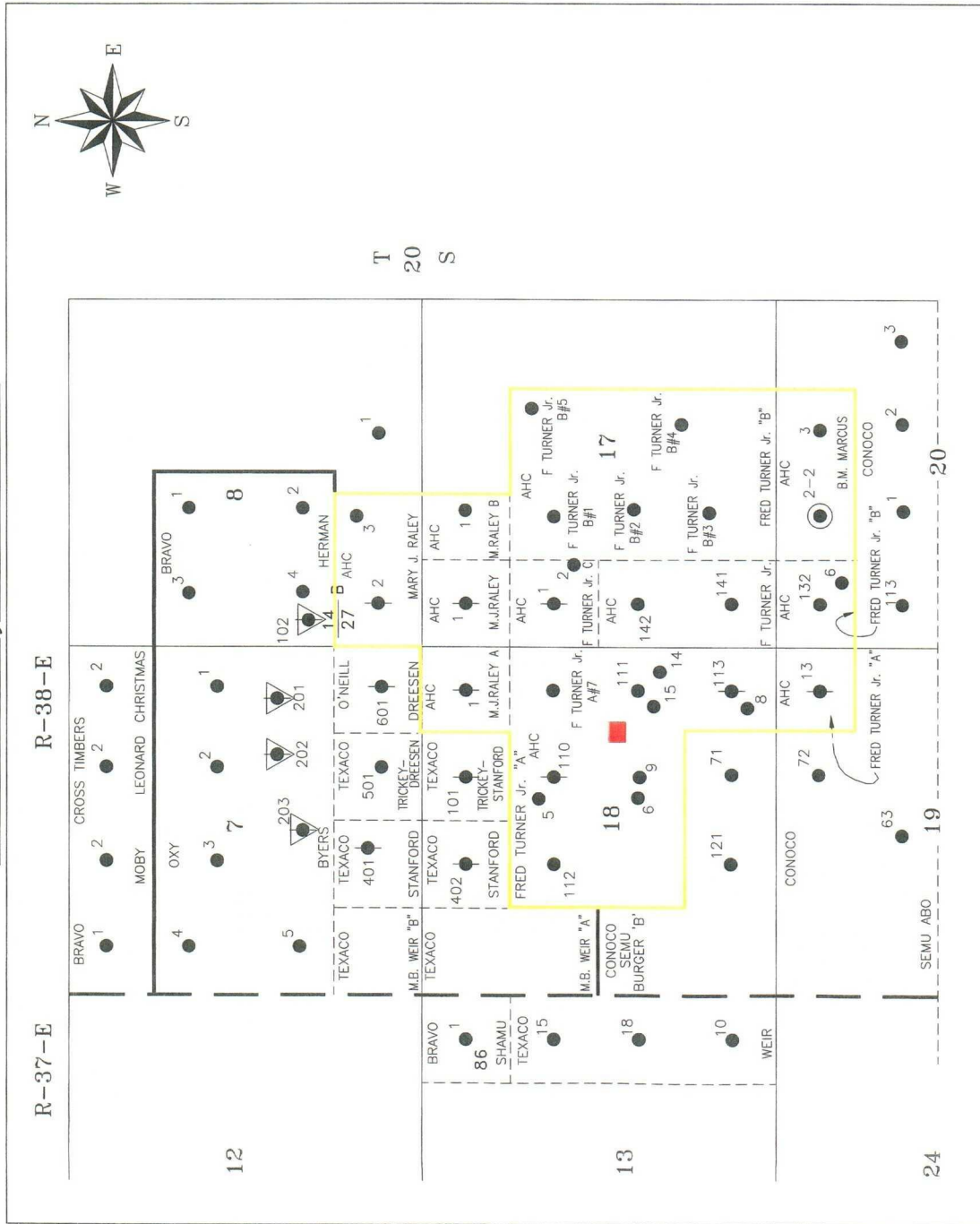

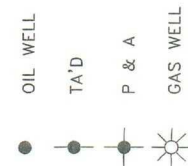

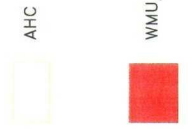
BASE MAP

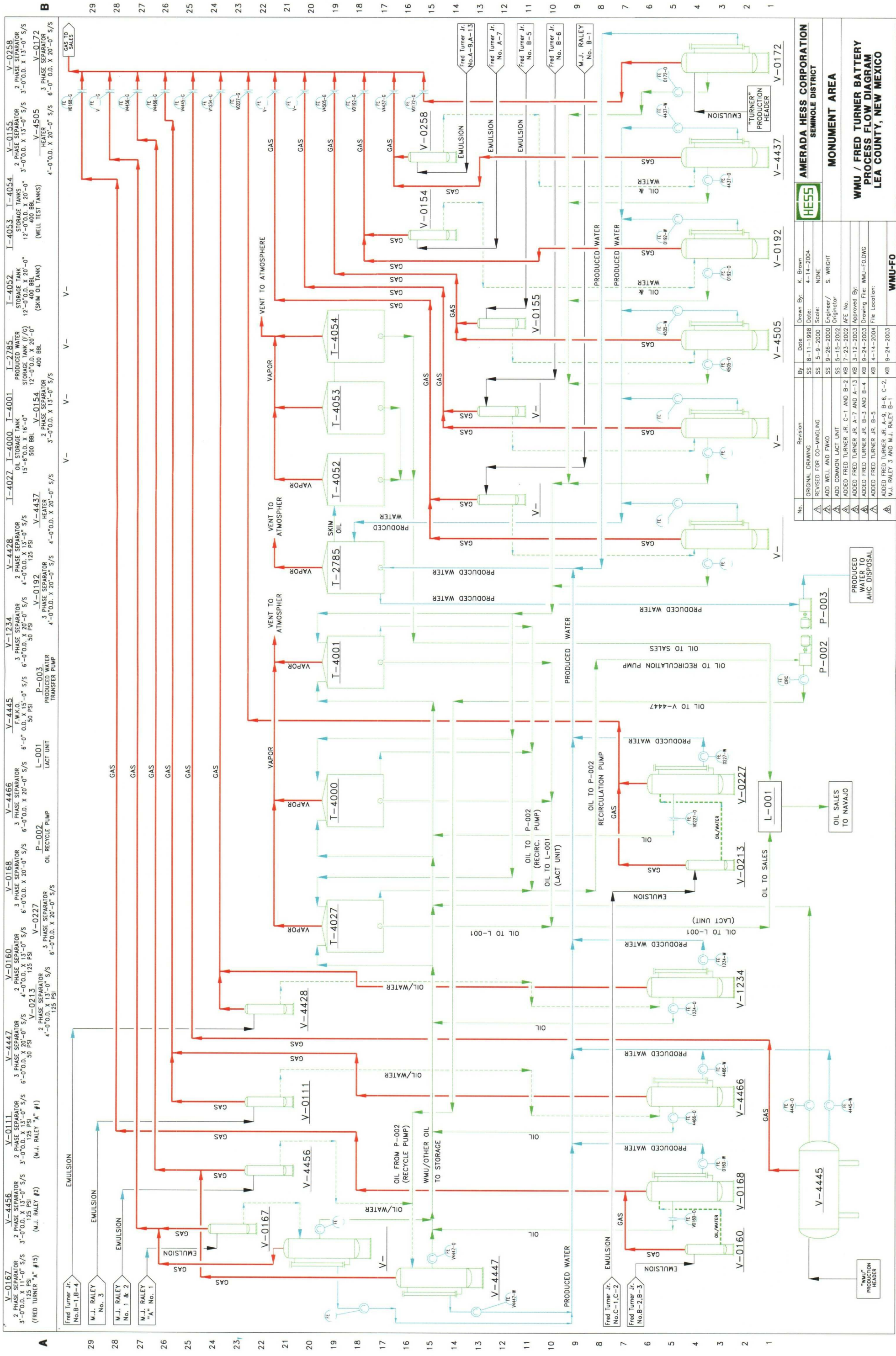
