XTO ENERGY INC.

FLORANCE 74

2250' FSL & 790' FEL SEC. 19, T. 27 N., R. 8 W., SAN JUAN COUNTY, NM

I. The well is on BLM surface and on BLM oil and gas lease (NMNM-0003380). The proposed location is nonstandard for the Blanco Pictured Cliffs South due to topography. A standard location must be at least 660' from the quarter line. This well is staked 270' further north than is standard. (Closest standard location would be 1980' FSL and 790' FEL.) The APD cover sheet is attached as EXHIBIT A.

II. A C-102 showing the well location and pro ration unit (SE4 Sec. 19) is attached (EXHIBIT B). Relevant parts of the BLM oil and gas lease (2,400.96 acres) are shown as solid lines on the attached (EXHIBIT C) copy of the Fresno Canyon USGS topo map.

The well encroaches on the NE4 Section 19. The Pictured Cliffs in that quarter section has been dedicated XTO's Florance D LS 12 which is 2,391' north and on the same lease. Pictured Cliffs acreage dedications (quarter sections) are shown on Exhibit D.

III. According to NM Oil Conservation Division records reviewed on January 16, 2005; the closest existing or planned Pictured Cliffs well is XTO's Florance D LS 12 well which is 2,391' north at 790' FNL & 1628' FEL 19-27n-8w and on the same lease. EXHIBIT E shows the proposed well site, Pictured Cliffs dedicated spacing units, and Pictured Cliffs wells (circled on map) within those dedications.

Registered letters were sent on January 15, 2005 to all of the offset interest owners. Copies of the postal receipts and letters are attached.

IV. A copy of the USGS map is attached (EXHIBIT F). The proposed well site is marked. Pro ration unit (dashed outline) for the Blanco Pictured Cliffs South gas is the 160.00 acre southeast quarter of Section 19, Township 27 North, Range 8 West, San Juan County, NM.

V. The nonstandard location is due to topography. The closest standard location is on the side of a \approx 500' high cliff on Blanco Mesa.


VI. Archaeology is not an issue.

BLM Oil & Gas Lease NMNM-0 003380




Pictured Cliffs Dedications & Wells






