Marathon Oil Company requests administrative approval for Non-Standard Gas Well Locations in the Eumont Gas Pool for the Bertha Barber Well No. 19 and the Elliott State Well No. 8. These wells are scheduled to be drilled by Marathon Oil Company in 2002.

We also respectfully request authorization to simultaneously dedicate these wells as follows:

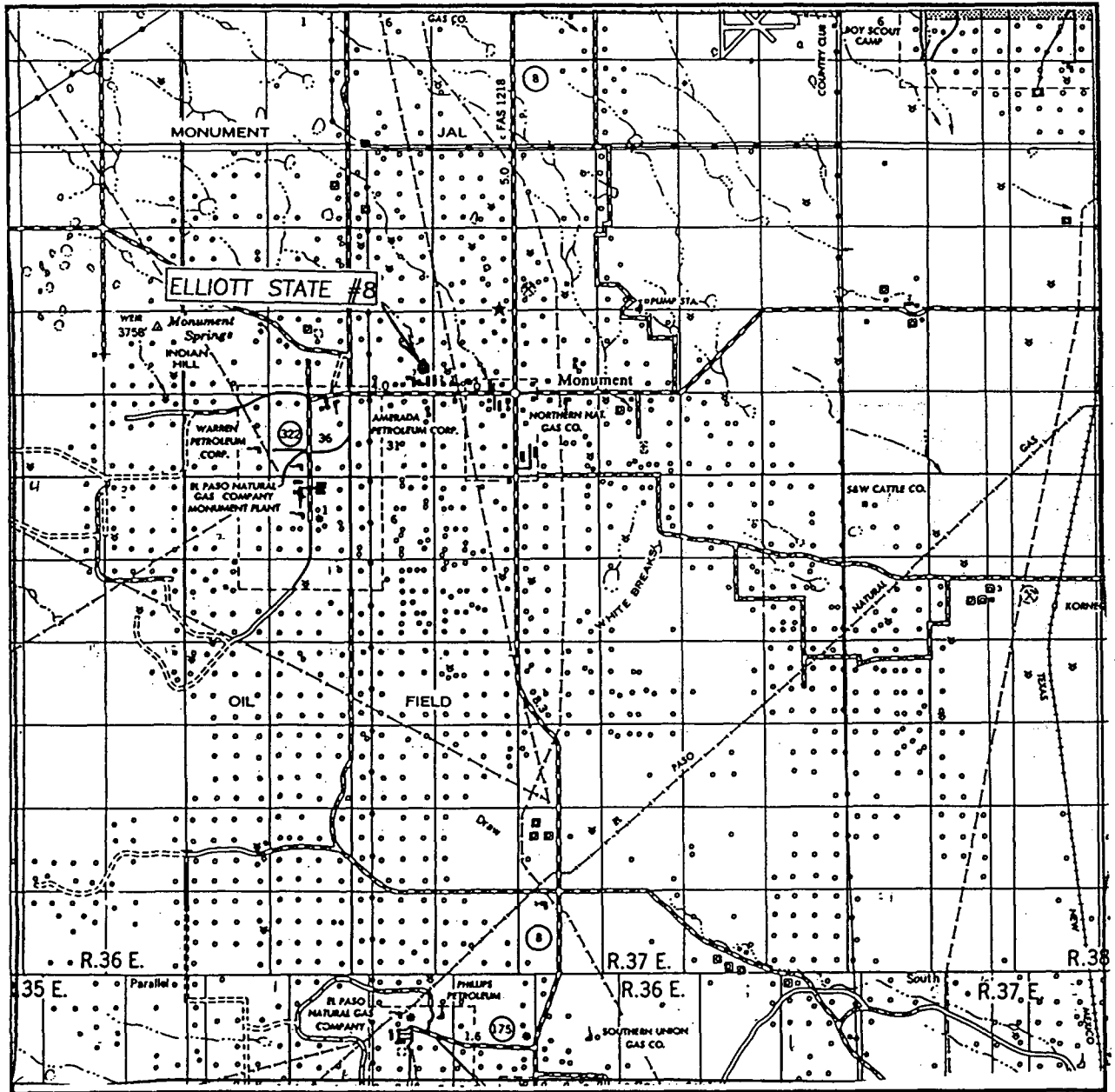
