Energen Resources Corporation (Energen) hereby requests Administrative Approval for an Unorthodox Location of its proposed Federal 28-8-28 #2S Fruitland Coal well under the provisions of New Mexico Oil Conservation Division (NMOCD) order R-8768.

This well is located 1075' fsl & 490' fel of Section 28-T28N-R8W, San Juan County, New Mexico and dedicated to a standard 320 acre spacing unit consisting of the S/2 of said section 28, in the Basin Fruitland Coal gas pool.

This well is closer than 660 feet to the eastern boundary of the proration unit, causing an unorthodox location. This location was moved to its current unorthodox location in order to move out of a wash.

A copy of this application is being sent to all affected owners by certified mail-return receipt request with a request that they furnish your office in Santa Fe a Waiver of Objection within twenty (20) days of receipt of this application.

Attached is a well location plat showing dedicated acreage (C-102), a plat showing the offsetting spacing units and Fruitland Coal wells, if any, and a topographic map.




