Mr. Hansen:

RICE Operating Company (ROC) has retained Rice Environmental Consulting and Safety (RECS) to address potential environmental concerns at the above-referenced site in the abandoned Hobbs Salt Water Disposal (SWD) system. ROC is the service provider (agent) for the Hobbs SWD System and has no ownership of any portion of the pipeline, well, or facility. The system is owned by a consortium of oil producers, System Parties, who provide all operating capital on a percentage ownership/usage basis.

On May 10<sup>th</sup>, 2013, RECS personnel were on site to supervise the plugging and abandonment of MW-1 and MW-2 according to the Termination Request submitted to NMOCD on April 18<sup>th</sup>, 2013 and approved on May 2<sup>nd</sup>, 2013. The wells were plugged with a 1-3% bentonite/concrete slurry and a three foot concrete cap.

ROC acknowledges they have met the requirements in accordance of 19.15.29 NMAC (Part 29; formally Rule 16), and the remediation plan (1R428-69) is terminated in accordance with 19.15.29 NMAC and no further action is required.
