You have requested to drill this directional well to an unorthodox bottom hole oil well location described above in the referenced pool or formation. This location is governed by statewide Rule 15.9.A [19.15.15.9.A NMAC], which provides for 40-acre units, with wells located at least 330 feet from a unit outer boundary. This location is unorthodox the bottom hole location is less than 330 feet from an outer boundary of the spacing unit.

Your application has been duly filed under the provisions of Division Rules 15.13 [19.15.15.13 NMAC] and 4.12.A(2) [19.15.4.12.A(2) NMAC].

It is our understanding that you are seeking this location for geologic reasons and to comply with United States Bureau of Land Management surface siting requirements.
